Individuals with no registered Sole Proprietorship and deregistered Sole Proprietorship

As part of work done by the ministry to establish an effective and efficient mechanism of expatriate workers management in the Maldives, MED has been updating and harmonizing the data related to expatriate workers, which includes data of employers. In this process it has been identified that, permits were issued to some individual employers for the purpose of commercial works without the necessary business registrations.

With reference to chapter 4, clause 11b and annex 1, clause 4a (2) of the Regulation on Expatriate Employment, a valid business registration is required for individuals who employ expatriate workers for the purpose commercial works. As per the Business Registration Act [18/2014] individuals who do commercial works need to register their business as a Sole Proprietorship.

Please be informed that you are required to have a registered Sole Proprietorship to maintain permits issued for commercial works. Therefore, please register a Sole Proprietorship before 15th November 2022. Failure to register will result in the suspension of services provided within the Xpat system.

Application for sole proprietorship registration can be submitted via online business portal (<https://business.egov.mv/>). However, An Efaas account is required to gain access to the online business portal.

As of now, Individual and Sole Proprietorship data are not displayed separately within the Xpat System. However, this issue will be addressed within the system with the upcoming updates to the xpat online system. If any permits were issued to you under domestic category, with this change, the domestic and commercial permits will be displayed to you separately.

Additionally, if you have appointed representatives to manage permits in Xpat system, any existing active relations to your individual account will be carried to your Sole Proprietorship. If any changes are necessary (such as the removal or addition of a new relation), please email a letter stating the required change along with the specifics to xpat@1500help.mv
